LEGISLATIVE ACTION ALERT



PA SB 168 TABLED

The PA Conference is pleased to announce that PA Senate Bill 168 (Previously PA SB 645) is off table. This bill, sponsored by Republican Senator Patrick J. Stefano would have required any proposed collective bargaining agreement be made available on the public employers' publicly accessible Internet website within 48 hours. An agreement must be posted online two weeks prior and thirty days following the signing of the collective bargaining agreement. The posting shall include the following information:

- 1. A statement of the terms of the proposed collective bargaining agreement;
- 2. An estimate of the costs to the public employer associated with the agreement.

Proposed collective bargaining agreements and any documents presented by the public employer or received from the employee organization in the course of collective bargaining are to be public records subject to the Right-to-Know Law.

The PA Conference will continue to monitor anti-labor legislation including these types of bills and lobby to defeat all legislation that can have an adverse impact on labor and working families.
