Shapiro: "Pennsylvania will never be a right-to-work state"

"This will never be a 'right-to-work' state," Shapiro told the audience, according to local outlet The Times Leader. "Never."

The PA Conference of Teamsters would like to congratulate Governor-elect Josh Shapiro and U.S. Senator-elect John Fetterman for their victories in the November 8, 2022 General Election.

Since its inception on February 2, 1984, the PA Conference of Teamsters has fought to keep Pennsylvania from becoming a "right-to-work" state.

Through the hard work of the PA Conference, Joint Council No. 53, Joint Council No. 40, Local Union Affiliates, our lobbyist, and the IBT, for the last 38 years, Pennsylvania has been spared the fate of becoming a "right-to-work" state.



There were many years that "right-to-work" legislation had been introduced in PA. Thankfully, with the due diligence of the PA Conference, Councils, Local Unions, our lobbyist, and the IBT, coupled with friends on both sides of the aisle, "right-to-work" never became a reality.

This election was critical in staving off this anti-union legislation. Regardless of your party affiliation, Shapiro **WAS** the only choice to protect your union and your contract, and that is why he received the PA Conference's endorsement.

<u>All elections are critical</u> in protecting your union, wages and contract. Electing anti-union candidates, in any of our Conference states, will only increase the risk of that state becoming a 'right-to-work" state.
